



## **Terms of Usage**

To help us make the Donalda and District Agricultural Society's (D.D.A.S.) Equestrian Centre a wonderful experience for everyone we ask this of you:

- Sign-in: All users & volunteers must sign the logbook with your name and time spent riding or volunteering.
- **NO PARKING** between the entrance door and the white storage shed, area is a driveway only.
- Manure Pick up your horse's manure using the fork and pails/wheelbarrow provided. Wheelbarrow and pails must be emptied, even if they are not full. Empty the wheelbarrow and pails in the manure containment box on west side of building. ALL MANURE MUST BE PICKED UP FROM THE INDOOR ARENA, OUTDOOR ARENA & PARKING LOT AREAS. Please respect this facility and the volunteer hours that go into maintaining it by cleaning up after yourself and your animals.
- NEW \*\* We ask all users bringing multiple horses to please tie or stall the additional horses outside in an effort to preserve our new ground and reduce ammonia in the arena.
- Equipment use Users may utilize the jumps & standards, barrels, round pen and cowboy challenge equipment provided by D.D.A.S. Equipment must be put away when not in use and before leaving the arena, If damaged, please notify a D.D.A.S. Director.
  - It is expected that all users have access to an obstacle free arena. As such, when other riders enter the arena, equipment & obstacles must be put away, unless being utilized by other users.
  - Obstacles include the above listed equipment, plus cattle, sleds or roping dummies.
- \* No smoking or cannabis use at any Donalda and District Agricultural Society's facilities.
- **Professional Services** Drop In or Rental Fee is to be paid for all services.
- ABSOLUTELY NO FARRIER work is to be done at the Equestrian Centre including the arena(s), parking lot and/or campground.
- Ventilation and Heat: The heat and ventilation is computer controlled. Please DO NOT touch the thermostats or fan controls.
- **Remember**: All the doors need to be locked and lights turned off when you leave.

**ABUSIVE BEHAVIOR WILL NOT BE TOLERATED:** Riding privileges may be suspended at the discretion of the Donalda and District Agricultural Society

Users found in violation or not abiding by the terms of the agreement may have the user privileges suspended or revoked at the discretion of the Donalda and District Agricultural Society Board of Directors.

**Booking Procedure:** All bookings must be made with 24 hours (1 days) notice or at the discretion of the booking agent. All bookings are to be pre-paid, unless other arrangements have been made.

**Cancellation Policy:** There is a 12 hour cancellation policy or at the discretion of the booking agent. Cancellations with no notice may be subjected to a 25% cancellation fee.

## **Private Booking Rates, Policies & Procedures Definitions**

*Day Rate:* defined as an 8 hour time period, horse stall usage including in a day rental. If a 2 day rental, horse stall usage overnight TBD at time of booking

*Weekend Rate:* defined as Friday 1pm to Sunday 6pm. Includes permanent stalls. Portable, temporary stalls are 50% of the going rate, set up of pens is responsibility of renters. Camping is extra and charged at going rate. Horses occupying horse stalls prior to or after the above designated dates and times are subject to the going rate.

*Drop In Rate:* defined as non-member usage, payable at the going rate per rider with a maximum of two (2) horses, additional horses extra fee per horse is applicable. All additional horses (over 2) are to be tied or stalled outside.

Family: defined as Parent(s)/Guardian(s) with children under 18, Married or Common Law Couples

*Professional Services:* defined as as coaching, equine massage, equine chiropractic, veterinarian, and all other services for which an individual is receiving payment for providing said service.



## Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement
